#### 12 Grass cutting at Tunstead Church

Cllr Powell proposed that TPC pay £400 this year to be reviewed yearly and TPC would want to see the invoice; seconded by Cllr Hetherington. Unanimous decision in favour of the motion.

#### 13 Scottow Enterprise Park incinerator plan

Cllr Place informed the meeting that the plant will be burning shredded cardboard as fuel and that it appeared that it would be really clean. Initially, there will be an application to run the operation for 30 days to analyse how the operation performed and what the impact was on the local community.

Cllr Coston asked about transportation of waste to site and whether this was a concern.

It was agreed to keep an eye on any progression of this application.

#### 14 North Walsham West

To consider a response from TPC

Nigel Dixon said that the public consultation would be starting soon and that TPC would want to consider the impact of the development regarding traffic on the B1150. Nigel said that a B1150 specialist interest group been formed. Nigel said that the junction which joins Tunstead to B1150 is of concern

#### 19 Neighbourhood Plan

Cllr Hetherington wants TPC to do NDP and influence planning. He said it was vital that TPC endeavours to find out what the community wants rather than assume what they want and then act on that assumption.

Cllr Hetherington has spoken to Locality, who provide funding to facilitate the creation of neighbourhood plans. They have said that there will be another round of funding coming up for 23/24 and that TPC would need to move quickly as the funding may not be carried over after the end of March 2024 and the opportunity for gaining funding could be lost. There are some issues regarding applying for funding as a planning officer at NNDC is refusing to designate Tunstead and

Sco Ruston as a designated area as he claims that Sco Ruston is separate to Tunstead. TPC need NNDC to designate TPC as the proper authority for Tunstead and Sco Ruston as funding is predicated on NNDC designating TPC as a proper authority for the area concerned. Further, the officer at NNDC wants to see minutes to show that a) TPC have voted that they want to undertake a neighbourhood plan, and that b) the signatory of an application has been given authority by TPC.

Cllr Coston proposed that TPC asserts that it wants to create a neighbourhood plan; Cllr Oakes seconded this. Majority vote in favour of the motion.

Cllr Powell proposed that TPC give Cllr Hetherington and/or Cllr Oakes full power to sign any application for funding to create a neighbourhood plan; seconded by Cllr Coston. Majority vote in favour of the motion.

Cllr Powell thanked Cllr Hetherington for all the work he was putting into the neighbourhood plan

#### **20 Tunstead Combined Charities**

The Clerk read out a brief report from Cllr Foulds which stated the following:

- Rent paid for anchor street paddock
- Work finished with pipe laying on Mill Lane land. We need to check with the tenant to see if everything has been finished satisfactorily
